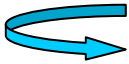

HELIUM Rebate Program

High Efficiency Landscape Irrigation Upgrade Measures HE Nozzle/Body/Pressure Regulation Rebate Voucher

Qualifications:

- Valencia Water Company (VWC) is offering up to 50% rebate for parts and pieces to our customers who purchase qualifying HELIUM devices including HE Spray Nozzles, HE Spray Heads/Bodies and/or Pressure Regulating Device(s). Rebate amounts will vary.
 - 25% for HE Spray Nozzles Only (See Qualifying Products List)
 - 50% for HE Spray Nozzles in Combination with HE Spray Bodies, or Master Pressure Regulation Device(s) (See Qualifying Products List).
- The residential property must be in the VWC service area.
- HELIUM devices must be purchased on or after September 1st, 2011, or before July 1st, 2012. Extensions on this rebate are at the discretion of VWC. Rebates available until funds last and are awarded on a first come, first serve basis.
- The HELIUM devices may be purchased at any retail or wholesale outlet that sells HE irrigation equipment.
- Bring your **original** sales receipt and completed documents to VWC along with other necessary documentation to substantiate the HE device(s) purchased are qualifying HELIUM Rebate products. Your documentation must include the date of purchase, purchase price, product/model information.
- HELIUM rebate voucher will be completed & executed by customer when HELIUM receipts are walked into our office.
- VWC will credit up to 50% of the total cost of parts and pieces, with an annual maximum allowable rebate amount of \$750.00, or 1 HE nozzle/body per 50sqft, whichever is less. (Excluding Taxes, Labor, and Non-Qualifying Devices).
- Please allow 8 weeks for your completed application to be processed.
- REBATES WILL BE ISSUED AS A CREDIT ON YOUR WATER BILL and VALENCIA WATER COMPANY WILL APPROVE 1 REBATE REQUEST PER CUSTOMER ACCOUNT PER YEAR (CUSTOMERS CAN SUBMIT MULTIPLE RECIEPTS IN THIER REBATE APPLICATION)**
